MEMBERSHIP: A membership in the Arrowhead Fish and Game Conservation Club (AFG) is limited to persons 18 years of age or older. Memberships run from January 1 through December 31 of each and are **not prorated**. There are two kinds of memberships: 1) the Single Person Memberships - 18 years of age and older; and 2) Family Memberships - husband, wife, and their children (17 years of age and younger). The membership does not include any other family members or friends. Non-members are not allowed on the AFG Range property at any time, except when the Range is open and the Range Master is present. A member is entitled to the following: 1) use of the Club Range Monday through Friday without charge except when under supervision of the Range Master or a Club Official; and 2) use of the Club Range (rifles, pistols, and shotguns) Saturdays and Sundays at the prevailing rate. Shooters **must** register and pay **before** shooting.

RESPONSIBILITIES OF MEMBERS: Members **must** wear their badges at all times on the Range Property. The badge **must not** be loaned/given to a minor family members or friends in order to allow these people to use the Range. Any violation of the following rules and requirements of the AFG Club may result in termination of one's membership.

RULES: 1) The AFG-appointed Range Master is in charge of the Range. 2) When the range is unsupervised, members must lock the gate upon entering and departing. 3) While at the Range, members must wear their membership badge and be prepared to show their badge to the Range Master or a Club Official. 4) For safety and protection, the use of eye and ear protection is mandatory for everyone at the Range, whether on the firing line or in the bleachers. 5) No drinking, smoking, or horseplay on the firing line. 6) All firearms must be in a case when transported from the parking lot to the firing line. 7) Only law enforcement officers are allowed to wear side arms. 8) All weapons are to be pointed down range at all times. 9) All weapons left unattended **MUST** be unlocked, the action left open, and an empty-chamber indicator inserted in the open action. 10) No tracer or armor-piercing ammo is to be used on the Range. 11) While targets are being placed, all shooters **must** stand behind the chain-link fence. 12) Do not walk on the berms - they are for your safety. 13) Use targets - not bottles. 14) All shooters are required to clean up and dispose of their own debris. 15) Cards and keys in the possession of non-members will be picked up and the member may be subjected to expulsion from the Club. 16) The Range key may not be duplicated.

I have read all of the rules and regulations above and I agree to obey all of them as a condition of my acceptance as a member. I understand that non-members and guest(s) are not allowed on the Range Property at any time except when the Range Master is present and the Club is open for business. I also agree and declare that 1) the benefits of membership and/or being able to use the Club's Facilities, even if on a temporary or limited basis, represent good and valuable consideration and 2) that in exchange for such consideration, I hereby agree to indemnify and hold harmless Arrowhead Fish and Game and all legal costs, including attorney fees and court costs, caused directly or indirectly by any and all intentional acts or negligence that may be attributed to my actions or inactions, and those of the members of my party whom I deliver to the Club's Property, or cause to utilize the Club's Facilities or to enter the Club Property. I further agree that any violation of the rules may also result in the termination and permanent exclusion of my membership.
